- 02. The bidder should fulfilled the following eligibility qualification criteria.
  - i. All bidders shall possess legal right to supply the Goods under this contract.
  - ii. A Bidder shall not have a Conflict of Interest.
  - iii. Registered as a business with the appropriate authority in Sri Lanka.
  - iv. Should have a valid Importation License issued by the National Fertilizer Secretariat.

- 03. All bids must be accompanied by a Bid Security Guarantee or Bank draft at the aforesaid value Issued by a licensed Commercial Bank registered under the Central Bank in Sri Lanka. The Bid Security Guarantee/ Bank draft required to be submitted for this purpose should be as above;
- 04. A complete set of bidding documents in English language could be purchased by the interested bidders from the Actg. Manager (Procurement & Imports) of the Ceylon Fertilizer Company Limited, Hunupitiya, Wattala, on payment in cash of a non-refundable bidding fees as above.
- 05. Bidding documents will be issued on any working day, between 9.30 a.m. and 3.30 p.m. up to 29.04.2024.
- 06. Bidding will be conducted through National Competitive Bidding Procedure (NCB).
- 07. The pre-bid meeting will be held on **22.04.2024 at 11.00 a.m.** at the Procurement Division of the Ceylon Fertilizer Co.Ltd., Hunupitiya, Wattala.
- 08. The envelope containing the sealed Bid should deposited in the Bidding Box kept for this purpose at the Head office of Ceylon Fertilizer Co.Ltd., Sri Lanka, send by hand or registered by post on or before **30.04.2024 at 2.30 p.m.** addressed to the detail given below.
